#### Agenda

\* MSC M. Cox/C. Kinney to approve the October 16, 2025 agenda.

\* MSC J. Bernal/C. Renda to approve the October 2, 2025 minutes. (3 abstentions)

## Information

- \* District CIC discussed the new accounting method and Credit for Prior Learning (CPL). It was noted that SDCCD is doing well in reporting CPL on transcripts.
- \* C. Kinney reported the Meta Steering Committee is working on getting the CIP Codes listed to be the same as the choices in COCI.
- \* At the Academic Senate meeting J. Estep abstained on the resolution regarding Supporting Strong Workforce.
- \* The Mesa Catalog Committee will meet on Tues 10/28/2025 via Zoom. The 2026-2027 Catalog proof is now available for review and Chairs and Deans are requested to sign off by 11/13/2025. The next catalog proof will be available sometime in December/January.
- \* I. O'Connor informed the committee that Mesa's Physical Therapist Assistant Baccalaureate Degree may not be approved for another year or two.
- \* J. Kalchik reported the Policies and Procedures Committee (PPC) is updating several Board Policies and Administrative Procedure documents by the first quarter of 2026 to reflect the Title 5 changes for more direct Inclusion Diversity Equity Antiracism and Accessibility (IDEAA) and Universal Design for Learning (UDL) language into all CORs by 2030. Our CRC committee needs to have a documented process for implementing IDEAA and UDL language into CORs and committee members need to start learning and be trained to review CORs for IDEAA and UDL language. It was recommended that liaisons from our committee be assigned to each of the departments to facilitate faculty in adding this language to CORs.
- \* M. Cox reported numerous trainings are being offered by E. Rabinovich regarding the Program Review process. The schedule can be found here: Training Schedule Fall 2025.
- \* N. Resch reported that at the next Committee of Chairs (COC) meeting on 10/22/25, Committee of Chairs Chair Ian Duckles and Veronica Gerace will run a working meeting to start the creation of a Chair's handbook. A curriculum section/sub-group will likely be established to cover curriculum related topics.
- \* J. Parker shared that the application to include Filipino American Studies to the Asian American/Pacific Islander minimum qualifications had been submitted to the Academic Senate for California Community Colleges (ASCCC) for review during the upcoming Area D meeting.
- \* There was no report on District GE.
- \* There was no update on Cal-GETC.
- \* C. Kinney reported eight language Liberal Arts & Science degrees are being deactivated for fall 2027 in response to the approval of the newly created LBAS in World Languages.
- \* J. Bernal had no updates on STEM Calculus/AB 1705.

- \* J. Estep reported on AB 1111. He reported that most Phase III surveys were due September 29, 2025 and that Phase IIB meetings were either scheduled or have already happened.
- \* J. Estep reported the ACCJC visit will happen on October 27, 2025. Guest E. Rabinovich was applauded in appreciation for her work in coordinating the listing of Outcomes in CORs.
- \* J. Estep reminded the committee of his status as CRC Co-Chair and requested that anyone who might want to be his successor beginning Fall 2026 should contact him and/or I. O'Connor as voting will take place in March 2026.
- \* J, Estep displayed the CCCCO's COR Memo handout and emphasized that Title 5 now charges curriculum committees with embedding IDEAA into CORs and to strengthen CORs the regulation now requires CORs to include explicit accounting of instructional and outside-of-class hours be listed and language regarding "basic skills" be updated.
- \* The inclusion of IDEAA in CORs will begin in Spring 2026 with training and more discussion happening then to include points listed in the CCCCO's COR Memo.
- \* Two new ADT templates (MATH 2.0 and PHYS 2.0) have been created for Fall 2026 implementation.
- \* J. Estep outlined the three main options for satisfactory completion of GE:
  - minimum "C" for the Areas 1A, 1B, and 2 (English Composition, Critical Thinking and Composition and Mathematical Concepts and Quantitative Reasoning) and 2.0 GPA for the other coursework.
  - "C" grade required for all coursework,
  - "2.0 GPA" for all coursework,
- \* A hand vote on these options showed eight for the minimum "C" for the Areas 1A, 1B, and 2 (English Composition, Critical Thinking and Composition and Mathematical Concepts and Quantitative Reasoning) and 2.0 GPA for the other coursework option, fourteen for the "C" grade required for all coursework option, and zero for the "2.0 GPA" for all coursework option.
